Flea Market Hours of Operation

Friday, September 17 - 8 a.m. to 8 p.m.

Saturday, September 18 - 8 a.m. to 8 p.m.

Sunday, September 19 - 8 a.m. to 3 p.m.

- 1 The flea market will be in the Flea Mkt. Building next to the TMF Craft Building. There will be limited outside spaces which will be assigned in the order in which they are received
- 1 Spaces are limited to approximately 14 ft. deep X 15 ft. wide (\$65.00 each), indoor on concrete, outside on grass, and will be measured and assigned
- 2 Vendors will be responsible for setting up their own displays including furnishing their own tables, chairs, and power cords.
- 3 Tables and displays must be set up on Thursday, September 16th after 1p.m. and not later than 8:00 p.m.; or Friday, September 17th between the hours of 6 a.m. and not later than 8:00 p.m.
- 4 The building will be locked at 8 p.m. each night. Security will be provided, however, the festival committee cannot be held responsible for damage, loss, or theft of any kind.
- 5 Minimal electricity will be available for a \$10.00 additional fee and will be given on a first request basis.
- 6 Spaces are \$65 for each 14 X 15 space. This fee will be due at the time you submit your application. Multiple spaces may be requested at the same rate (\$65 per space). **This money is not refundable.**
- 7 Type of ware displayed/sold must be consistent with the description set forth on the application
- 8 Your money will be refunded by August 15th if your application is not accepted.

- 9 Any special request should be written on the application and we will try to accommodate. Please keep in mind that early requests will be considered first. All requests may not be granted due to the large number of vendors expected to participate.

- 10 Limited camping spaces with electricity are available for the vendors in the area across from the flea market building upon request. These spaces will be given on a first request basis. You must pre-pay to assure a space. The fees will be **\$25. without** electricity and **\$35. with**. This fee should be included with your returned application.

- 11 Those vendors knowingly violating festival rules and regulations will be asked to leave the grounds.
